- 2. The Bidders/Fabricators with experience successfully completing fabrication and supply of steel parts for minimum five trail Bridges within last five years enlisted By DoLIDAR are eligible for bidding. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLIDAR may also apply. However Bids of Such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

A complete set of Bidding Documents may be purchased from Bhageshwor Rural Municipality Office OF Rural Municipal Excutive, Bagarkot, Dadeldhura by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 1000.00 till 2076/02/30 during office hours.
- Sealed quotation must be submitted to the Bhageshwor Rural Municipality, Office Of rural Municipal Excutive, Bagarkot, Dadeldhura by hand on or before 12:00 on 2076/02/31. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2076/02/31 and 14:00 hrs. at the Bhageshwor Rural Municipality Office Of Rural Municipal Excutive, Bagarkot Dadeldhura, Sudur Paschim Province Nepal. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 17000, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No 4020303007105 at Rastriya Banijya Bank Dadeldhura Branch and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
